## **Business Practices & Material Issues**

Adoma has identified electricity, water, and A4 paper usage as key material issues in relation to natural resource consumption. We actively monitor these resources by keeping monthly records of usage. While no specific concerns have been raised by external stakeholders, we recognize the need to manage these resources efficiently to reduce costs and minimize environmental impact.

#### **Actions & Outcomes**

Adoma has a policy in place to promote the responsible use of electricity, water, and other natural resources, which are accessible to employees via our Line group chat and to external stakeholders through our website. In 2024–2025, our main focus has been on reducing electricity use from conventional energy sources such as coal and gas. To achieve this, we installed solar panels at our facility in February 2025 to reduce reliance on fossil-fuel-based electricity and lower our environmental impact. We have tracked solar energy generation and savings since installation, integrating the data into our monthly resource monitoring.

For water and A4 paper, we continue to maintain close monitoring and plan to implement targeted reduction initiatives in the coming years.

In addition to the solar installation, we have continued other energy-saving practices, including switching off unused equipment and installing heatreflective roofing to reduce air-conditioning needs. The data shows promising reductions in electricity consumption since the solar panels became operational.

### Senior Management Oversight

Mr. Thanakorn Sathaponkanarak, Safety Officer, is responsible for reviewing Adoma's electricity, water, and other natural resource consumption, ensuring that records are maintained and improvement plans are developed.

#### **Improvements Against Last Year**

Compared to the previous year, Adoma's most notable improvement has been in electricity management, highlighted by the installation of solar panels in early 2025. While a full-year savings comparison is still underway, early records indicate reduced electricity costs by approx. 10% or 2000 Units of electricity.

## Future Commitments & Clean Energy Frameworks

Adoma remains committed to continuous improvement in natural resource conservation. We will continue to closely track our water and paper usage and explore practical ways to reduce consumption in the future. These efforts reflect our ongoing commitment to minimizing environmental impact while supporting the long-term sustainability of our business and the broader jewellery supply chain.
